

Notice under Personal Data Protection Code, subscribed at the time of customer registration

In compliance with Section 13 of Legislative Decree no. 196/2003, "Personal Data Protection Code" please be informed that personal data provided from filling in the form, shall be processed by the Company Villa Luigi entitled to the personal data processing.

#### 1. Definition of personal data processing

The processing of personal data, that shall be supplied to the Company Villa Luigi, means any operation involving collection, recording, organisation, keeping, elaboration, modification, selection, retrieval, comparison, utilisation, interconnection, blocking, communication, erasure and destruction, or involving a combination of two or more than such operations.

#### 2. Purposes of personal data processing

Personal data supplied shall be processed by the Company Villa Luigi for the purposes here below: a) filing in relation to data required for the classification of correspondence, for phone book or any contact book not for disclosure, exclusively used for job purposes; b) fulfilment of legal obligations, and data shall be processed for no longer than it is necessary to comply with all legal obligations.

#### 3. Methods of processing data

The data processing shall be carried out by paper, computerised and telematic means, also via internet. With reference to surfing data, computer systems and software procedures in charge of the functioning of that web site acquire, during their normal use, some personal data whose transmission is implied in internet protocols. It is a case of information that weren't collected to be associated to identified subjects, but that, for their own nature, could permit to identify the customer through processing and associations with data kept by third parties. In that category of data, there are IP addresses or domain name of computers of users who connect to the website, URI addresses (Uniform Resource Identifier) of queries, the queries time, the method of querying the server and other parameters regarding operating systems and user's computer: above information are obtained just in case user sends e-mails. Cookies are not used to process personal data. The session cookies won't be recorded lastingly on user's computer and will be deleted as the computer browser closes.

#### 4. Disclosure of personal data

Data can be communicated and/or supplied: a) in cases and to subjects required by law; b) to external subjects who perform specific duties on behalf of Villa Luigi in relation to the purposes herein listed.

#### 5. Refusal to provide personal data

Data provision for the purposes of the hereabove point 2 is not compulsory but necessary to supply the services required by the customer. The possible refusal of data provision for those purposes involves, in consequence, the impossibility, for the company, of being able to supply what required. The customer, under article 130 of Legislative Decree 196/2003 can deny the use of his/her own email address in order to receive communications regarding goods and services similar to those for what he/she logged in the website [www.villasunshine.it](http://www.villasunshine.it)

#### 6. Rights of customer and contacts to exercise the rights

In relation to personal data processing, customer shall have the rights under article 7 of Legislative Decree 196/2003, and in particular, the right of obtaining from the data controller confirmation of the existence or otherwise of their own personal data and availability of same in an intelligible form; the customer has the right to know the origin of the personal data, the purposes and methods of processing, the logic applied to processing; the customer has the right of the erasure, the blocking of any personal data processed in violation of the law and she/he has the right have the personal data updated, corrected or supplemented; the customer has the right to object to processing of the personal data for legitimate reasons. All possible requests of blocking, erasure, transformation shall be sent to Villa Luigi, through registered mail to the above address, or via e-mail to [villa@villasunshine.it](mailto:villa@villasunshine.it)
